# RESUMPTION AND CONTINUATION OF CLASSES FOR SEMESTER I/II OF THE 2020/2021 ACADEMIC YEAR

- 1. The portal will be opened for continuation of registration for the Semester under reference from Tuesday 8<sup>th</sup> June 2021 for a period of four (4) weeks. Students are required to PAY FEES AND FULLY REGISTER during this period. The portal will close on Sunday 4<sup>th</sup> July 2021 at 11.59 p.m.
